

Please note that certificate will be issued only to registered authors. The selected papers can be presented as a power point presentation or as E-posters. Structured abstracts of the papers selected for presentation will be published in the conference proceedings.

Abstracts submitted under Paper/Poster presentation to the Krupacon 2023 conference proceedings will be short-listed for full-length manuscript submission in Scopus/WoS indexed journal.
